- Supporting internal litigation on IP-related proceedings, challenges, disputes and litigation

  - Data protection for new pharmaceutical products in CA, US and Europe; (including new chemical entities, orphan drug designation, pediatric extension, CSPs, etc.)
  - PMNOC regulations in Canada and basic understanding of Hatch-Waxman litigation process in the US.
